Yields Rise; Earnings in Focus.

Markets Rise on Strong Economic Data

Markets briefly hit record highs above 7,500 on Thursday before pulling back on Friday. Treasury yields rose across the curve, while precious metals declined as Fed Chair Kevin Warsh began his term. President Trump traveled to China, where agreements included Chinese investment in U.S. farmland, purchases of 200 Boeing planes, and greater access for U.S. industries in China. On the economic front, both CPI and PPI came in elevated, driven by higher energy prices. Retail sales were also strong, reflecting consumer spending continues to remain resilient. Shipping traffic in the Strait of Hormuz has remained subdued, leading to tighter supply and higher energy prices.

For the Week...

The S&P 500 (+0.2%) and the tech-heavy Nasdaq Composite (-0.1%) continued to make new record highs week. The Dow Jones Industrial Average briefly re-captured 50,000 but closed slightly below it and finishing flat for the week. Small-cap stocks declined on higher interest rate concerns, with the Russell 2000 down 2.3%.

Consumer Inflation Reaccelerates on Energy Costs

Headline CPI inflation rose 0.6% in April, matching expectations, while the annual rate increased to a 3-year high of 3.8%. Core CPI inflation rose 0.4% M/M, above expectations (+0.3%), lifting the annual rate to 2.8%.

Weekly Sector Insights

4 of the 11 sectors ended the week higher, led by Energy (+7.0%) as crude oil edged higher this week. Consumer Staples (+1.3%) and Information Technology (+1.2%) also edged higher. Consumer Discretionary (-3.0%) and Real Estate (-2.6%) edged lower this week.

Treasury Yields Rise

The yield on the 10-year Treasury note rose sharply from 4.36% to 4.60% this week on inflation concerns. Bond yields move inversely to prices. The U.S. Dollar Index was also up 1.4%. U.S. WTI crude oil edged 7.5% higher on supply concerns. Gold edged lower, falling 3.2%.

The Week Ahead

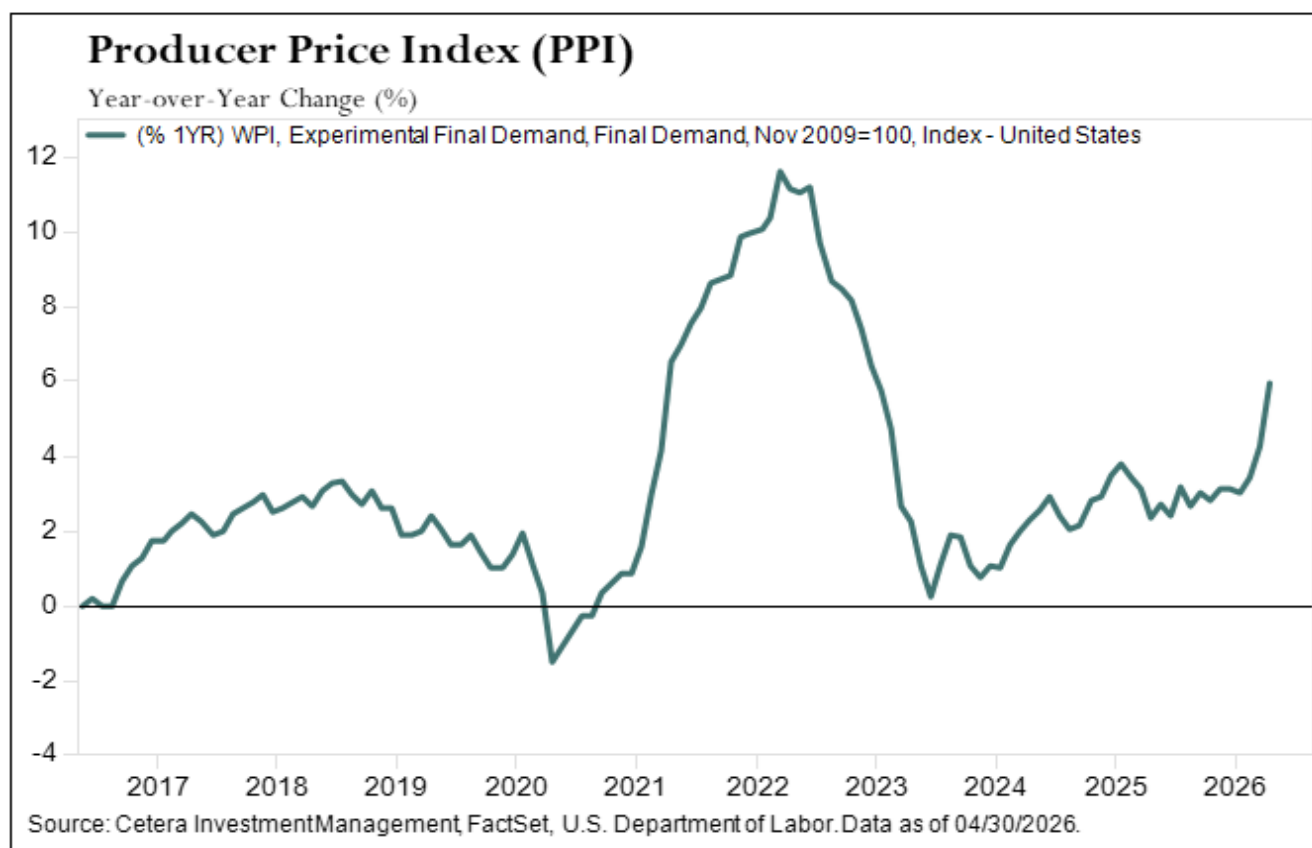
Bond yields remain a key focus, with further increases likely to pressure equities in the short term. Nvidia, currently the largest company in the world, reports earnings this week, offering insight into AI trends. Retail earnings will also be closely watched, with forward guidance providing a read on consumer strength.

Chart of the Week: Producer Prices Surge



The Producer Price Index (PPI) surged 1.4% in April, far outpacing expectations of +0.5%, pushing the annual rate to a 40-month high of 6.0%. Price pressures weren't limited to energy. Final demand services increased the most since March 2022.

Glossary

The **Dow Jones Industrial Average** is a price-weighted average of 30 significant stocks traded on the New York Stock Exchange and the NASDAQ.

The **S&P 500** is an index of 500 stocks chosen for market size, liquidity and industry grouping (among other factors) designed to be a leading indicator of U.S. equities and is meant to reflect the risk/return characteristics of the large cap universe.

The **NASDAQ Composite Index** includes all domestic and international based common type stocks listed on The NASDAQ Stock Market. The NASDAQ Composite Index is a broad based index.

The **Russell 2000 Index** measures the performance of the small-cap segment of the U.S. equity universe and is a subset of the Russell 3000 Index representing approximately 10% of the total market capitalization of that index. It includes approximately 2000 of the smallest securities based on a combination of their market cap and current index membership.

The **Russell 3000 Index** measures the performance of the largest 3,000 U.S. companies representing approximately 98% of the investable U.S. equity market.

The **Russell Midcap Index** measures the performance of the mid-cap segment of the U.S. equity universe and is a subset of the Russell 1000 Index. It includes approximately 800 of the smallest securities based on a combination of their market cap and current index membership.

The **Bloomberg US Aggregate Bond Index**, which was originally called the Lehman Aggregate Bond Index, is a broad based flagship benchmark that measures the investment grade, US dollar-denominated, fixed-rate taxable bond market. The index includes Treasuries, government-related and corporate debt securities, MBS (agency fixed-rate and hybrid ARM pass-throughs), ABS and CMBS (agency and non-agency) debt securities that are rated at least Baa3 by Moody's and BBB- by S&P. Taxable municipals, including Build America bonds and a small amount of foreign bonds traded in U.S. markets are also included. Eligible bonds must have at least one year until final maturity, but in practice the index holdings have a fluctuating average life of around 8.25 years.

The **Bloomberg US Corporate High Yield Index** measures the USD-denominated, non-investment grade, fixed-rate, taxable corporate bond market. Securities are classified as high yield if the middle rating of Moody's, Fitch, and S&P is Ba1/BB+/BB+ or below, excluding emerging market debt. Payment-in-kind and bonds with predetermined step-up coupon provisions are also included. Eligible securities must have at least one year until final maturity, but in practice the index holdings has a fluctuating average life of around 6.3 years.

The **Bloomberg US Municipal Bond Index** covers the USD-denominated long-term tax exempt bond market. The index has four main sectors: state and local general obligation bonds, revenue bonds, insured bonds, and prerefunded bonds. Eligible securities must be rated investment grade (Baa3/BBB- or higher) by Moody's and S&P and have at least one year until final maturity.

The **MSCI EAFE** Index is designed to measure the equity market performance of developed markets (Europe, Australasia, Far East) excluding the U.S. and Canada. The Index is market-capitalization weighted.

The **MSCI Emerging Markets Index** is designed to measure equity market performance in global emerging markets. It is a float-adjusted market capitalization index.

The **Bloomberg Commodity Index** is a broadly diversified index that measures 22 exchange-traded futures on physical commodities in five groups (energy, agriculture, industrial metals, precious metals, and livestock), which are weighted to account for economic significance and market liquidity. No single commodity can comprise less than 2% or more than 15% of the index; and no group can represent more than 33% of the index.

The **S&P GSCI Crude Oil Index** is a sub-index of the S&P GSCI, provides investors with a reliable and publicly available benchmark for investment performance in the crude oil market.

The **S&P GSCI Gold Index**, a sub-index of the S&P GSCI, provides investors with a reliable and publicly available benchmark tracking the COMEX gold futures market.

The **U.S. Dollar Index** is a weighted geometric mean that provides a value measure of the United States dollar relative to a basket of major foreign currencies. The index, often carrying a USDX or DXY moniker, started in March 1973, beginning with a value of the U.S. Dollar Index at 100.000.
